### **Who is Gay V. Weake?**

Gay V. Weake was the Executive Director of the Sun Valley Center for the Arts from 1997-2001. A lifelong admirer of the arts and humanities, Ms. Weake graduated from Smith College and enjoyed a successful career in international business before moving to Sun Valley. During her tenure at The Center she recognized that talented young people living in Blaine County often lacked the advanced opportunities for independent studies in the arts and humanities that many students in larger cities enjoy. In response, she created the Scholarship Fund at the Sun Valley Center Wine Auction. The funds go to deserving Blaine County students who need financial assistance pursuing summer arts camps, independent studies with local artists, and other enrichment activities. The scholarship program has expanded beyond her original vision and now includes four separate scholarships: the program for high school students pursuing independent study in the arts and humanities, the Ezra Pound Scholarship for high school juniors studying visual arts, the Gay V. Weake Scholarship for college students pursuing the arts and humanities, and the fourth scholarship for teachers pursuing professional development in the arts and humanities. None of this would have occurred without her vision.

### **Scholarship Description & Eligibility**

The Gay V. Weake Scholarship is for Blaine County high school students entering or continuing college, preference will be given to those majoring in visual arts and/or performing arts; some humanities will be taken into consideration (art history & creative writing). Consideration will only be given to full-time students. Children of full-time Center employees and board members are not eligible for scholarships.

### **Scholarship Amount**

This is a renewable award of up to \$2000 per year in college. It only covers tuition at an accredited college or university and is awarded to one to four students annually.

### **How are scholarships determined?**

Grants will be awarded to Blaine County residents based on their interest, experience, ability, and enthusiasm for their chosen area of study. Financial need will also be taken into consideration.

### **1. Description of your intended college and major course of study**

- One from a teacher.
- One from someone who is familiar with your experience in your field of study. **No relatives.**

### **3. Sample of your work**

- Digital images, clips or links of your work are preferred. All CDs and DVDs will be returned to you with your notification. Only include work completed within the last two years.

### **4. Transcript**

- Please provide an official transcript from your college or high school registrar's office. Mail it directly to The Center (P.O. Box 656 Sun Valley, ID 83353). An overall 2.5 GPA is required and a 3.0 GPA in courses from your major curriculum are required to be considered for this scholarship.

### **5. Financial information**

- Please submit the first two pages of your parents' tax returns from the last two years. If your parents file separately, we will need information from each of them.
- Fill out and attach the financial information cover sheet to your tax returns.

### Reports

Each scholarship recipient is required to submit a written report about what he or she learned from his or her experience. Videos, tapes, and images are also welcome as part of the report. Reports can be found on the Sun Valley Center for the Arts website [www.sunvalleycenter.org](http://www.sunvalleycenter.org). Reports will be due on **Monday, January 12, 2015**. **Students who do not submit reports by this date are ineligible for future scholarships.**

- Gay V. Weake scholarship recipients do not have to apply annually for the award. To renew the scholarship, recipients must complete the report yearly, have official transcripts sent to The Center; maintain status as a full time student in the designated major, and an overall 2.5 GPA and a 3.0 GPA in courses in their major curriculum.

### Payments

Checks will be mailed directly to the student's school. Students need to contact The Center upon receipt of scholarship notification to confirm which school they are attending and to provide a mailing address for the school's accounting office.

### Judging

Applications are judged by a Scholarship Committee. Members of this committee change yearly and are an independent group. Please read the following suggestions from past committee members on how to best present you in an application:

- APPLICATIONS MUST BE TYPED.
- Be sure the application is complete and all directions are followed.
- Spend time on your essays and make sure that your interest is clearly expressed.
- Have a proposal focused toward definable goals.
- Have someone proofread your application.
- Don't forget to follow up with your recommenders. Did they send it? Did you remember to thank them? Recommendations play a large role in the committee's assessment of each application.
